**-- Information under Section 4 of J&K RTI, Act, 2009.**


The functioning of Settlement Organization of Revenue Department is to complete Settlement Operations i.e. (up-dation of land records like preliminary verification, measurement and preparation of records) in the State. Another important task which the authorities of this Organization perform are to hear the appeal cases. New villages are created by bifurcating / trifurcating / quadrifurcating bigger villages during the process of Settlement Operations. Settlement Commissioner is HoD who is working under the overall control of Financial Commissioner, Revenue.
