In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Sh. Sahil Kumar S/o Late Sh. Balwant Singh (deceased Naib Tehsildar) R/o Bishnah District Jammu as **Orderly** in the pay scale of **Rs. 4440-7440** + Grade pay of **Rs 1300/-** under **SRO-43 of 1994** against an available vacancy identified by the Deputy Commissioner, Jammu in Revenue Department in District Jammu.

The appointee shall report to Deputy Commissioner, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only production of the following documents/certificates to be verified subsequently:-

1. **Academic qualification certificate.**
2. **Date of Birth certificate.**
3. **Permanent Resident certificate**
4. **Medical Fitness certificate.**
5. **Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.**
6. **All other relevant certificates/Documents required under norms.**

The appointee shall be initially on probation for a period of two years, if, on verification, the certificate produced by the appointee prove to be fake or forged, the appointment shall stand as cancelled ab-initio in terms of the circular instructions issued by General Administration Department vide circular No. 17-GAD of 2012 dated 07.6.2012.

Further, the salary of the appointee shall not be drawn and disbursed to the appointee unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner, Jammu. He shall furnish an affidavit to the effect that in case any adverse report about his character and antecedents is received from the IGP, CID, J&K he shall have no right to claim the appointment as Class-IV in Revenue Department District Cadre Jammu and shall be deemed to have been cancelled ab-initio.


