In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of **Miss Neelofar Mohi-ud-din D/o Late Ghulam Mohi-ud-din Sheikh R/o Zachaldara Tehsil Handwara District Kupwara as Junior Assistant** in the pay scale of Rs. 5200-20200+Grade pay of Rs 1900/- under **SRO-43 of 1994** against an available vacancy identified by the Deputy Commissioner, Kupwara in Revenue Department in District Kupwara.

The appointee shall report to Deputy Commissioner, Kupwara within a period of 21 days from the date of issuance of this order and shall be allowed to join only production of the following documents/certificates to be verified subsequently:-

1. Academic qualification certificate.
2. Date of Birth certificate.
3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.
7. Type test certificate.

The appointee shall be initially on probation for a period of two years, if, on verification, the certificate produced by the appointee prove to be fake or forged, the appointment shall stand as cancelled ab-initio in terms of the circular instructions issued by General Administration Department vide circular No. 17-GAD of 2012 dated 07.6.2012.

Further, the salary of the appointee shall not be drawn and disbursed to the appointee unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner, Kupwara. She shall furnish an affidavit to the effect that in case any adverse report about her character and antecedents is received from the IGP, CID, J&K, she shall have no right to claim the appointment as Junior Assistant in Revenue Department District Cadre Kupwara and shall be deemed to have been cancelled ab-initio.


