**Subject: Appointment of Patwari (Revenue Department) District Cadre Doda item No. 681 (06 of 2015) under SRO-202.**

In pursuance of selection made by the Service Selection Board, J&K Jammu and endorsed/recommended by the Administrative Department vide their letters referred to above, **Sh. Shiver Kumar S/o Madan Singh R/o Buttla P/o Saringal Tehsil Bhaderwah District Doda under ST Category** is hereby appointed temporarily as Patwari in the Revenue Department, District Cadre Doda, in the pay level-4 of Rs 25500-81100.

The appointee shall report to Principal Revenue Training Institute, Jammu, within a period of 21 days from the date of issuance of this order. The selected candidate may be allowed to join subject to the following conditions:

- a) The appointee(s) shall be allowed to join only on production of the following certificates (in original) to be verified subsequently.
1. Academic/Technical Qualification Certificates.
  2. Matriculation/Date of Birth Certificate.
  3. Health Certificate from the concerned Chief Medical Officer of the District.
  4. Permanent Resident Certificate issued by the Competent Authority
  5. Certificate from the District industries Centre (DIC) and District Employment & Counseling Centre to the effect to the effect that no loan under the self employment scheme has been taken by the appointee.
  6. Relevant category certificate.
- b). The appointment of the above candidates(s) shall further be subject to the following conditions:-
- i. The appointee(s) shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Additional Director General of Police (CID), J&K he shall have no right to claim his appointment as Patwari in District Cadre Doda, and his appointment, as such shall be deemed to have been cancelled ab-initio.



- II. Verification/genuineness of the qualification, reserved category certificate and recognition of the computer institutes from the concerned issuing authorities.
- III. The salary of the appointee(s) shall not be drawn and disbursed to him unless the satisfactory report of (i) and (ii) above are received in his favour.
- IV. If, on verification, the certificates produced by the appointee proved to be fake or forged, his appointment shall stand as cancelled ab-initio;
- V. The appointment of the above candidates shall be governed by the New Recruitment Policy as per **SRO-202 of 2015 dated 01.09.2015**
- VI. The appointee shall be initially on probation for a period of five years and after completion of five years his service shall be declared as permanent under SRO-202 of 2015 subject to passing of such tests, or successfully undergone such as provided under the J&K Civil Services (Classification, Control & Appeal) Rules 1956 or as prescribed under relevant recruitment rules governing the post/service to which he has been appointed.
- VII. The inter-seniority of the appointee(s) shall be derived in accordance with the merit.
- VIII. If the candidate(s) fails to join within a period of 21 from the date of issuance of the appointment order they shall forego their right to appointment which shall be deemed have been cancelled ab-initio without any further notice.
- IX. The appointment of the above candidate(s) shall be subject to outcome of writ petition(s) if any pending before Competent Court of Law.
