- Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by the appointee.
- 6. All other relevant certificates/Documents required under norms.

The appointee shall be initially on probation for a period of two years, and if, on verification, the certificate produced by the appointee are proved to be fake or forged, the appointment shall stand cancelled ab-initio in terms of General Administration Department circular No. 17-GAD of 2012 dated 07/6/2012.

Further vide Circular instruction issued by General Administration vide Circular No. 08-JK(GAD)of 2019, Dated 04.12.2019,in the case candidate fails to join within a period of 21 (twenty one) days from the date of issuance of this appointment order shall forego his right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

Further, the salary of the appointee shall not be drawn and disbursed to the appointee unless verification/genuineness of the qualification certificate from issuing authority and verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner, Samba. Appointee shall furnish an affidavit to the effect that in case of any adverse report about his character and antecedents, he shall have no right to claim the appointment as Orderly in Revenue Department, District Cadre Samba and his appointment shall be deemed to have been cancelled ab-initio.
