Whereas among others Sh.Chetan Kundal S/o Daya Krishan Kundal R/o H.no. 110 F, Lance No. 3 Janki Vihar Old Janipur Jammu OM/SC Revenue Department District cadre Jammu was selected as Junior Assistant vide this office Order No.FC (Adm) 179 of 2016 dated 26.10.2016; and

Whereas, while examining the case in this office in terms of Jammu and Kashmir Revenue (Subordinate) Service Recruitment Rules, 2009 it revealed that since the said Junior Assistant was still on probation and is not interested to serve in Revenue Department on his own will as such his resignation is accepted and his services are liable to be terminated.
