- (v) Dependent Certificate issued by the Assistant Commissioner, Revenue
- (vi) No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- (vii) All other relevant document as required under SRO43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

- (b) That he shall give an under give an undertaking in the shape of an affidavit to the effect that:-
- (vii) In case an adverse report about his/her Character and Antecedents is received from the Additional Director General of Police(CID), J&K, to whom a reference shall be made by the Deputy Commissioner, Poonch he shall have no right to claim his appointment, which, shall be deemed to have been cancelled ab-initio.
- (viii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- (b). The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed have been cancelled ab-initio, without any further notice.
