**Subject:- Acceptance of Resignation of Sh. Prashant Sharma, MTS – Discharge thereof.**

Whereas, on the recommendations of the Service Selection Board, J&K conveyed vide Letter No. SSB/Secy/Class-IV/2021/7103-11 dated 18.10.2021, Sh. Prashant Sharma S/o of Tara Chand Sharma R/o Wno. 16 Near Dn Palace Udhampur was appointed as Class IV by the Revenue Department vide Order No:- 92-JK(Rev) of 2021 dated 22.10.2021.

Whereas, vide Government Order No:- 92-JK(Rev) of 2021 dated 22.10.2021, among others the service of Prashant Sharm, MTS was placed at the disposal of Deputy Commissioner Udhampur.

Whereas, Sh. Prashant Sharma has joined Government Service on 27.10.2021 in the office of Deputy Commissioner Udhampur.

Whereas, subsequent to his appointment as MTS the said official has tendered his resignation on 13.06.2023 on the grounds that he has been selected as Junior Assistant in Jal Shakti Department (PHE) vide order No. PHEJ/GE/52/E of 2023 dated 10.06.2023.

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the said official is still on probation and has not qualified the prescribed service.

Therefore, in exercise of the powers conferred under Rule 22(1)(b) of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and under Rule 4 of J&K Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules 2020 notified by SO 192 of 2020 dated 17.06.2020, the resignation tendered by Prashant Sharma S/o of Tara Chand Sharma R/o Wno. 16 Near Dn Palace Udhampur is hereby accepted and his probation period is terminated accordingly. He is discharged from the Government Service from the date of his resignation i.e. 13.06.2023.


