Subject: Appointment of Patwari Trainees through J&K Board of Professional Entrance Examination (BOPEE) Revenue Department, District Cadre Srinagar under SRO 400 of 2009 dated 24.12.2009.

Reference: Administrative Department's letter No. Rev/NG/15/2011-III dated 10/04/2019.

As recommended by the Administrative Department vide their letter referred to above, Sh.Dawood Rasool Dar S/o Ghulam Rasool Dar R/o Rambagh Srinagar is hereby appointed temporarily as Patwari in the Revenue Department, District Cadre Srinagar in the pay level-4 of Rs 25500-81100.

The appointee shall report to Deputy Commissioner, Srinagar within a period of 21 days from the date of issuance of this order. The appointment of the candidate may be allowed to join subject to the following conditions:

1. Genuineness of Academic qualification certificate/ Date of Birth certificate/ Category Certificate/ Permanent Resident Certificate and all other relevant certificates/ Documents required under norms.
2. The Interim arrangement, if any, made against the above post(s) on deputation or temporary basis shall be deemed to have been terminated forthwith and the incumbent if in service reverted to his original cadre.
3. The post is available as on date and stand referred to the J&K Service Selection board.
4. The appointment in District Cadre is not transferable from one district to another and change of cadre is not acceptable.
5. The appointment of the said candidates shall be governed by "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
6. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
7. The appointment of the candidate is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
8. If the candidate does not join within the stipulated period of 21 days, he may be informed through leading News papers to report in the department otherwise his services may be terminated under rules.
9. The officer responsible for receiving/accepting joining report of new appointee shall solicit "No Objection Certificate" from Labour and Employment Department,

to the effect that the name of the concerned appointee has been deleted from the list of eligible beneficiaries under "VSA" as mentioned by the concerned department/respective District Employment & Counseling Centre, as well as from District Industries Centre (DIC).

10. The appointment order will be governed by Circular instructions issued by the General Administration Department vide Circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.
11. The Deputy Commissioner, Srinagar shall ascertain genuineness of the qualification certificates/ documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing salary of the appointee.
12. The Deputy Commissioner, Srinagar shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/ forged, for further course of action. If on verification the certificates produced by the appointee are proved to be fake/forged, the appointment shall be cancelled ab initio.
13. The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
14. In case of receipt of an adverse report and on confirmation thereof by the State/ Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
