

Whereas, 195 Girdawars were placed as Incharge Naib Tehsildars vide this office Order No. FC (A) 162 of 2014 dated 30.7.2014.

Whereas, out of these 195 Incharge Naib Tehsildars, 147 were regularized against the posts of Naib Tehsildars by the State Level Departmental Promotion Committees in the meetings held on 26.6.2018, 24.10.2018 and 24.10.2019 and the cases of 38 Incharge Naib Tehsildars were deferred for deficiency of requisite documents viz APRs, Vigilance clearance etc and the cases of 10 Naib Tehsildars were kept in sealed cover.

Whereas, the cases of remaining 38 Incharge Naib Tehsildars were again placed before the State level Departmental Promotion Committee held on 30th June 2020 and it was decided to confirmation/regularize only six In-charge Naib Tehsildars whose APRs/vigilance clearance have been received and the remaining 32 Incharge Naib Tehsildars who failed to submit the pre-requisite documents viz APRs/Service Bio-data etc. were again deferred for regularization and it was also decided that a final opportunity be given to them to file APRs/Service Bio-data etc till 30th July, 2020, failing which they shall be utilized for next in line eligible officials without any further notice.

Now, therefore, as per the approval of the State Level Departmental Promotion Committee in its meeting held on 30th June, 2020, the following Incharge Naib Tehsildars are regularized in the substantive capacity as Naib Tehsildars in the pay scale of Rs 9300-34800 + Grade pay Rs 4280 (Pre-revised) 6E (35900-113500) revised from the dates shown against each:-
