The Deputy Commissioner Ganderbal shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing their salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab intio.
9. The salary of the appointees shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
10. In case of receipt of an adverse report and on confirmation thereof by the State/Divisional/District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
