Subject: Initiation of Regular Departmental Action [RDA] against Mr. Abdul Gani Wani, the then Patwari and Mr. Bikram Singh, the then Addl. Patwari Halqa Pariwan, District Kulgam.

Whereas, the Administrative Department vide No.Rev/Vig/24/2017 dated: 09.03.2017 forwarded the case for initiation of RDA against Mr. Abdul Gani Wani, the then Patwari and Mr. Bikram Singh, the then Additional Patwari of Halqa Pariwan of District Kulgam, which was forwarded to the Divisional Commissioner, Kashmir on 16-05-2017 with the request to initiate the RDA against the delinquent officials in terms of the J&K Classification, Control & Appeal Rules, 1956 and intimate the action taken.

Whereas, the Divisional Commissioner, Kashmir's report dated: 29-03-2018, 09-07-2018 and dated: 02-03-2019, the RDA has been got conducted through the Deputy Commissioner, Kulgam who has considered the case and found both the officials, namely, Mr. Abdul Gani Wani, the then Patwari and Mr. Bikram Singh, the then Additional Patwari of Halqa Pariwan of District Kulgam were prima-facie involved for making fraudulent/false assertion regarding incorporation of Section 4 of the J&K Agrarian Reforms Act, in respect of the land under survey No.176 and misrepresented the facts.

Whereas, the Deputy Commissioner, Kulgam has issued orders to impose penalty to both the delinquent officials, namely, Mr. Abdul Gani Wani, the then Patwari and Mr. Bikram Singh, the then Additional Patwari of Halqa Pariwan, of District Kulgam vide No.DCK/SQ/465/17 dated: 27-02-2018 with fine of one month's salary (March-2018) in terms of rule-30 (ii) of J&K Civil Services (Classification, Control and Appeal) Rules 1956 being the competent authority /cadre controlling authority of the officials; and the fine has been deducted vide District Treasury Kulgam Voucher No.05 dated 10-04-2018 by the Tehsildar, Kulgam.


Now, therefore, in view of the above facts and circumstances of the case, since the Regular Departmental Action has already been taken in the matter by the competent authority viz; Deputy Commissioner, Kulgam against the delinquent officials, namely; Mr. Abdul Gani Wani, the then Patwari and Mr. Bikram Singh, the then

Additional Ptuari of Halqa Pariwan of District Kulgam, the case is accordingly disposed of as closed with above action.

However, the Deputy Commissioner, Kulgam is instructed to dispose of the RDA cases in future within his competence by issuing a speaking order, with directions to concerned DDO to make necessary entry in relevant records including the instant case.
