Subject: Appointment of Patwari in Revenue Department under Hon'ble PM's Special Package for Kashmir Migrants item No. 147 District Cadre Kulgam

In pursuance to selection made by the Service Selection Board, J&K Srinagar and endorsed/recommended by the Administrative Department vide their letters referred above, **Qurat UI Ain D/o Ali Mohd Koka R/o 27-A, Hospital Road, Opposite Govt Hospital Jammu** is hereby appointed temporarily as Patwari under Hon'ble PM's Special Package for Kashmir Migrants, District Cadre Kulgam, in the Revenue Department, in the pay level-4 of Rs 25500-81100.

The appointed candidate shall report to Principal Revenue Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order. The appointment of the candidate may be allowed subject to the following conditions:-

- a) The appointment order of such appointee shall be deemed to be terminated if at any stage, it emerges that the certificates /documents produced by the concerned are fake or forged.
- b) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about her character/antecedents is received from Additional Director of Police, CID J&K to whom a reference shall be made by the Principal Revenue Training Institute, Srinagar, and the appointment of the candidate shall be deemed to have been cancelled ab-initio.
- c) Verification of all the certificates like Date of Birth, Qualification, Migration from the concerned issuing authorities and verification of Permanent Resident Certificate/Domicile Certificate from the concerned authorities through Relief and Rehabilitation Commissioner (M) Jammu.
- d) The salary of appointee shall not be drawn and disbursed to her unless satisfactory report in respect of (b) & (c) above is received.

- e) The appointee shall have to execute an agreement with the Government on the form, forming annexure to the Jammu & Kashmir Migrants or Kashmir Pundits (Special Drive) Recruitment Rules, 2009 notified Vide SRO-412 of 2009 dated 30.12.2009 read with SRO-425 of 2017 dated 10.10.2017.
- f) The appointment of the above candidate shall be governed as per S.O192 dated 17th of June, 2020 issued by the General Administration Department under endorsement No. GAD/Mtg/RB-IV/23/2020 Part-I dated 17.06.2020.
- g) The appointment shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- h) If the candidate fails to join within a period of twenty one (21) days of the issuance of this order, she shall forgo her right to appointment which shall be cancelled forthwith and in case the appointee migrates from Kashmir Valley at any time during her service tenure, for any reason whatsoever her appointment/service shall stand terminated without any notice.
- i) The appointment is subject to the writ petition if any, pending before any court of law.
