**Subject: Compassionate appointment of Ms.Zarina Maqbool D/o Late
Mohammad Maqbool Wani R/o Molu Tehsil and District Shopian as
Orderly under SRO-43 of 1994.**

In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22/02/1994, as amended from time to time, and as recommended by Deputy Commissioner, Shopian, sanction is hereby accorded to the temporary appointment of **Ms.Zarina Maqbool D/o Late Mohammad Maqbool Wani R/o Molu Tehsil and District Shopian as Orderly in the pay Level-1 of Rs 14800-47100 (SL1)**, under SRO-43 of 1994 against an available vacancy in Revenue Department, under District Cadre Shopian.

The appointee shall report to Deputy Commissioner, Shopian within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates to be verified subsequently:-

1. Academic qualification certificate.
2. Date of Birth certificate.
3. Domicile Certificate
4. Health Certificate from the Concerned Chief Medical Officer of District.
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department
6. All other relevant certificates/Documents required under norms.

The appointment of the appointee, shall further be subject to the following conditions:-

(a) That She Shall give an undertaking in the shape of an affidavit to effect that:

(I). In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Deputy Commissioner, Shopian, she shall have no right to claim her appointment as Orderly and her appointment as such, shall be deemed to have been cancelled ab-initio;

(II) If, on verification, genuineness of qualification certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Orderly shall also be deemed to have been



cancelled ab-initio and legal action as warranted under rules shall be initiated against her.


- (b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (I) and (II) above is received in her favour.
- (c) The appointee shall be on probation for a period of two years initially.
- (d) The appointment of candidate shall be governed by "New Pension Scheme" as per SRO-400 of 2009 dated 24.11.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
