Subject: Transfer and Postings in the Revenue Department.

**ORDER: 123 - FC (REV) of 2023
DATED: 20.03.2023**

Vide General Administration Department (GAD) Order No. 796 JK (GAD) of 2021 dated:26.08.2021, it has been ordered that transfer of Tehsildars, Naib Tehsildars shall be effected by Divisional Commissioner concerned, who shall place their services at the disposal of the Dy. Commissioners, for further postings within their respective district. Dy. Commissioners shall be competent to affect transfers and postings of the Tehsildars, Naib Tehsildars, Girdawars and Patwaries within respective district and also to assign charge of any such vacant post till regular arrangement in respect of such vacancy is made.

In view of delegation of powers at different levels, to ensure effective resource management and efficient working of the revenue hierarchy, while adhering to instructions regarding transfer window, premature transfers, etc. as well as to obviate possibility of multiple orders, it is hereby ordered that:

a) The transfer at UT level by the FCR shall be effected from 1st – 10th April, followed by the Divisional Commissioner at divisional level from 11th – 20th April and, thereafter, by the Dy. Commissioners;

b) If any posting has been made specifically by a higher office, it shall not be changed under delegated powers by a subordinate level without prior approval of the said higher office;

- c) No officer who has been posted to rural areas or outside capital (Jammu/Srinagar) districts shall be posted back till he completes at least two years, without approval of the FCR;
- d) No officer of the rank of the Tehsildar or Naib Tehsildar shall be posted in Capital (Jammu/Srinagar) districts or in the headquarter Tehsil of any district for more than half of service tenure, unless approved by the FCR.
