In continuation to this office Order No. 102/FC (Revenue) of 2020 Dated 15.05.2020, No. 106-FC (Revenue) of 2020 dated 05.06.2020, 112-FC(Revenue)of 2020 dated 19.06.202, 128-FC(Revenue) of 2020 dated 15.07.2020, No.130-FC(Revenue) of 2020 dated 31.07.2020 and No. 150 -FC(Revenue) of 2020 dated 24.08.2020 and as recommended by the J&K Services Selection Board and in pursuance of the Revenue Department's vide above quoted communications, sanction is hereby accorded to the appointment of **Shri Abdul Islam Khan S/o Abdul Rehman Khan R/o Dhargloon Tehsil Mendhar Distt. Poonch S.No. 02 ALC (Category)** as Naib Tehsildar (state cadre) on temporary basis in the Revenue Department in the pay level -6E (35900-113500).

The candidate shall report to the Principal Revenue Training Institute, Jammu, within a period of 21 days from the date of issuance of this order.

(A)The appointee shall be allowed to join only on production of the following certificates (in original) for verification:-

1. Academic/Technical Qualification Certificates.
2. Matriculation/Date of Birth Certificate.
3. Health certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate issued by the Competent Authority.
5. Certificates from the District Industries central (DIC) and District Employment & Counseling centre to the effect that no loan under the self employment scheme has been taken by the appointee
6. Relevant category certificate.



(B) The appointment of the candidate, shall further be subject to the following conditions:-

- i. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about character and antecedents is received from the Additional Director General of Police (CID), J&K, he shall have no right to claim his appointment; as such, his appointment shall be deemed to have been cancelled ab-initio;.
- ii. Verification/genuineness of the qualification, reserved category certificate and other related certificates from the concerned issuing authorities;
- iii. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of condition (i) &(ii) above are received in his favour;
- iv. The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009
- v. The appointee shall be on probation initially for a period of two (02) years.
- vi. If on verification the certificates produced by the appointee proves to be fake or forged, his appointment shall stand cancelled ab-initio;
- vii. The inter-se-seniority of the appointee shall be decided in accordance with the merit.
- viii. If the aforesaid appointee fail to join with in a period 21 days from the date of issuance of appointment order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice
- ix. The appointment of the above appointee shall be subject to the outcome of writ petition, if any, pending in the competent court of Law.
