- 4. Permanent Resident Certificate issued by the Competent Authority.
- 5. Certificates from the District Industries central (DIC) and District Employment & Counseling centre to the effect that no loan under the self employment scheme has been taken by the appointee
- 6. Relevant category certificate

(B) The appointment of the candidate, shall further be subject to the following conditions;-

The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about character and antecedents is received from the Additional Director General of Police (CID), J&K, he shall have no right to claim his appointment, as such, his appointment shall be deemed to have been cancelled ab-initio;.

- Verification/genuineness of the qualification, reserved category certificate and other related certificates from the concerned issuing authorities; ii.
- The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of condition (i) &(ii) above are iii. received in his favour;
- The appointee shall be governed under New Pension Scheme as per iv. SRO-400 of 2009 dated 24.12.2009
- The appointee shall be on probation initially for a period of two (02) years. ٧.
- If on verification the certificates produced by the appointee proved to be ٧i. fake or forged, his appointment shall stand as cancelled ab-initio;
- The inter-seniority of the appointee shall be derived in accordance with the vii. merit.
- If the aforesaid appointee fail to join with in a period 21 days from the date viii. of issuance of appointment order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice
- The appointment of the above appointee shall be subject to the outcome ix. of writ petition, if any, pending in the competent court of Law.
