 - Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
 - 6. Relevant category certificate.
 - 7. The appointees shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police (CID), J&K they shall have no right to claim their appointment for the said post, as such, shall be deemed to have been cancelled ab-initio;
 - 8. Verification/genuineness of the qualification, reserved category certificate and recognition of the Computer Institutes from the concerned issuing authorities;
 - 9. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (7) and (8) above are received in their favour:

- 10.1f, on verification, the certificates produced by the appointees proved to be fake or forged, their appointment shall stand as cancelled ab-initio;
- 11. The appointment of the above candidate (s) shall be governed by the new Recruitment Policy as per SRQ 202 of 2015, dated:30.06.2015;

The appointees(s) shall be initially on probation for a period of five years and after completion of five years his service shall be declared as permanent under SRO 202 of 2015 subject to passing of such tests, or successfully undergoing such training, as provided under the J&K Civil Services (Classification, Control & Appeal) Rules, 1956 or as prescribed under the relevant recruitment rules governing the post/service to which he/she has been appointed;
 - 13. The inter-seniority of the appointees shall be derived in accordance with the merit:
 - 14. If the candidate(s) fails to join within a period of 21 days from the date of issuance of the appointment order they shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice and
