The appointees shall be initially on probation for a period of two years, if, on verification, the certificate produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio in terms of General Administration Department circular No. 17-GAD of 2012 dated 07.6.2012.

The salary of each appointee shall not be drawn and disbursed to the appointee unless a satisfactory report about the verification of his/her character and antecedents is received from the Inspector General of Police, CID. Each appointee shall furnish an affidavit to the effect that in case of any adverse report about his/her character and antecedents, he/she shall have no right to claim the appointment as Junior Scale Stenographer in Revenue Department (State Cadre) and his/her appointment shall be deemed to have been cancelled ab-initio.
