3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.

6. All other relevant certificates/Documents required under norms.
7. The candidate of the appointee shall be cancelled without any notice in terms of circular instructions issued by the General Administration Department vide circular No. 17-GAD of 2012 dated 07/06/2012. If any of the testimonials/certificates are found fake or forged.
8. The Deputy Commissioner Kupwara shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/Institution/Department before drawing their salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab initio.
9. The salary of the appointee shall not be drawn and disbursed to the appointee unless satisfactory report about verification of his character and antecedents is received from Inspector General of Police (CID) to whom a reference shall be made by the Deputy Commissioner Kupwara.
