3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.
7. The appointment orders will be governed by Circular instructions issued by the General Administration Department vide circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.

The Deputy Commissioner Anantnag shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing their salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab intio.
9. The salary of the appointees shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
10. In case of receipt of an adverse report and on confirmation thereof by the State/Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
