As recommended by the J&K Service Selection Board Srinagar and endorsed by the Administrative Department vide their letter referred to above, **Gorav Gupta S/o Satpal Gupta R/o Ward No. 12 House No. 158 near Paba Gali, Udhampur** under **OM category** District Udhampur is hereby appointed as Junior Assistant in the Revenue Department in the pay scale of Rs 5,200-20,200 grade pay of Rs. 1,900/-

The appointee shall report to Deputy Commissioner, Udhampur within 21 days from the issuance of order for further adjustment as Junior Assistant in District Udhampur. The appointee shall be allowed to join only after production/verification of the following certificates in original.

1. Academic qualification certificate.
2. Date of Birth certificate.
3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.
7. The appointment order is governed by Circular instructions issued by the General Administration Department vide circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.

8. The Deputy Commissioner Udhampur shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing his salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab initio.
9. The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
10. In case of receipt of an adverse report and on confirmation thereof by the State/Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
