Whereas, based on recommendation of J&K Service Selection Board, the Revenue Department vide letter No. Rev/NG/237/2013 dated 04/10/2016 forwarded select list of candidates for the post of Junior Assistants (District Cadre) to this Office for issuance of appointment orders; and

Whereas, accordingly vide this Office Order No. FC(ADM) 184 of 2016 dated 26/10/2016 formal appointment order was issued in favour of Mr. Rajinder Kumar S/o Girdhari Lal R/o Gajore Pouni Reasi as Junior Assistant under OM Category, District Reasi in the Revenue Department and directed him to report to Deputy Commissioner Reasi for further adjustment; and


Whereas, Deputy Commissioner Reasi vide his letter No. DC/Rsi/N/658 dated 13/06/2017 has intimated that Mr. Rajinder Kumar S/o Girdhari Lal R/o Gajore Pouni Reasi has resigned from his office on 13/05/2017 and has forwarded the resignation of Mr. Rajinder Kumar dully endorsed by the Tehsildar Pouni vide letter No. The/N/676 dated 19/05/2017 to this office for further necessary action; and

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that Mr. Rajinder Kumar was still on probation and has not completed the probation period on account of which he is liable to be discharged from the service, by terminating his probation in terms of

Rule 21(2)(a), on his own request.

Now, therefore, in exercise of the powers conferred under Rule 21(2)(a) of the J&K, Civil Service (Classification, Control and Appeal) Rules, 1956, the probation of Mr. Rajinder Kumar S/o Girdhari Lal R/o Gajore Pouni Reasi as Junior Assistant under OM Category is hereby terminated and he is discharged from the Revenue (subordinate) Services w.e.f 13/05/2017, on his own request.




