As recommended by the J&K Service Selection Board, Jammu and endorsed by the Administrative Department vide their letters referred to above, the below mentioned candidates are hereby temporarily appointed as Junior Scale Stenographer in the Revenue Department, Divisional Cadre, Kashmir, in the Pay Level 6B (Rs. 35600-112800):-

The appointees shall report to Divisional Commissioner, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of following documents/certificates to be verified:

1. Academic qualification certificate/ Date of Birth certificate/ Category Certificate/ Permanent Resident Certificate and all other relevant certificates/Documents required under norms.
2. The interim arrangement, if any, made against the above post(s) on deputation or temporary basis shall be deemed to have been terminated forthwith and the incumbent if in service reverted to his original cadre.
3. The posts are available as on date and stand referred to the J&K Service Selection board.
4. The appointments in Divisional Cadre, Kashmir are not transferable from Divisional Cadre, Kashmir to State/District Cadre.
5. The appointees shall be on probation for a period of two years.
6. The appointment of the said candidates shall be governed by "New Pension Scheme" as per SRO 400 of 2009 dated 24/01/2009.
7. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.



8. The appointment of the candidates is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
9. The appointments are governed under the relevant provisions of SRO-375 dated 21/10/2010 issued by the General Administration Department.
10. If the candidates does not join within the stipulated period of 21 days, they would be informed through leading news papers to report in this Office otherwise his services would be terminated under rules.
11. The officer responsible for receiving/accepting joining report of new appointee shall solicit "No Objection Certificate" from Labour and Employment Department, to the effect that the name of the concerned appointee has been deleted from the list of eligible beneficiaries under "VSA" as mentioned by the concerned department/respective District Employment & Counseling Centre, as well as from District Industries Centre (DIC).
12. The appointment order will be governed by Circular instructions issued by the General Administration Department vide Circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.
13. If on verification the certificates/documents produced by the appointee are proved to be fake/forged, the appointment shall be cancelled ab initio.
14. The salary of the appointees shall be drawn and disbursed to the appointees only after receipt of character and antecedents verification report from Inspector General of Police (CID).
15. In case of receipt of an adverse report and on confirmation thereof by the State/ Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
