

Sir,

Regarding the subject and reference cited herein above, the point No. 1,2,3 of the complaint does not pertain to this office. However, point No. 4-7 of the complaint pertains to us. The point wise reply is given as under:-

Point No. 4:-The first complaint regarding the non-issuance of ROR (Parte Patwar) is not correct.

Since Oct. 2013 this office has issued 33 ROR,s (Parte Patwar) of the villages which comes under our jurisdiction till date.

Point No. 5:- Raised by the complainant is about low progress.

The basic reason is that after creation of new Tehsils and Naibats, all the Settlement Assistants/ Prism-men who were engaged in Settlement process were transferred to new Tehsils for office work. It hampered the progress of Settlement/ measurement work.

Point No.6:-Is about in-efficiency of NT's and Tehsildars regarding the techno-smart operation.

The fact is that the villages completed in Settlement process were verified by NT's and Tehsildars before deposition of Records in Record Room. However, it would be better to identify the names of officers who according to complainant are inefficient so that further action in the matter can be taken

Point No.7:- That there are not enough public servants who could carry the updation of Land Records.

It is to some extent correct. This complaint has been answered herein above at point No. 5.

However, for information RAMTECH Software solutions has been assigned the task to carry out the Settlement process and Scanning/ updation of all records.
