In terms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22.02.1994, sanction is hereby accorded to the temporary appointment of Feroz Ahmad Ganie S/O Late Ghulam Mohammad Ganie (Ex-Orderly) R/O Budgam as Class-IV in the pay scale of Rs.4440-7440 with the Grade pay of Rs.1300/- in the Revenue Department (District Cadre Budgam) in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The Financial Commissioner (Revenue) J&K shall allow the above named candidate to join on production and verification of the following certificates/documents in original and fulfillment of other codal formalities as required under rules:-

1. Academic Qualification Certificate.
2. Age & Health Certificate.
3. Permanent Resident Certificate.
4. No loan certificate under self employment scheme from DIC concerned and employment department.
5. Dependent certificate issued by the Assistant Commissioner (Revenue).
6. All other relevant documents as required under SRO-43 of 1994.

The appointee shall be on probation for a period of two years. If on verification certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled *ab-initio*. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report about verification of his Character and antecedents is received from Inspector General of Police (CID) to whom a reference shall be made.
