- (vi) Valid relevant Category Certificate.

- (b) The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities.
- (c) The appointee shall be initially on probation for a period of two years in accordance with the J&K Revenue (subordinate) Service Recruitment Rules, 2009.
- (d) The appointment of the candidate shall be governed by the "Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020" notified vide SO 192 of 2020 dated 17.06.2020.
- (e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (f) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services(Classification, Control and Appeal) Rules, 1956.
- (g) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed have been cancelled ab-initio, without any further notice.
