## **CIRCULAR**

It has come to notice of the Authorities that the Time Bound/In-situ Promotion cases of the non gazetted staff in the Revenue Department are not being processed in time. As a result, a number of requests for sanction of the in-situ promotion cases are received after a lapse of considerable time from the due date, followed by requests for arrear claims in the office of Financial Commissioner Revenue J&K. This has been viewed seriously by the authorities.

All the Controlling Officers are directed to ensure that all Time Bound/In-situ Promotion cases be processed and submitted to this office within a period of 01 month for the due date. The DDOs shall be personally responsible if the admissible cases are not submitted in time.

Further the following documents / record is required to be appended with each case to avoid unnecessary delay in the sanction of such cases :

- i. APR's of last 03 years attested in all respects
- ii. Integrity certificate and work and conduct certificate.
- iii. Vigilance clearance certificate
- iv. Under taking in terms of Schedule 2 & Form of option Schedule -3.
- v. Service Bio-data attested by concerned DDO.

A monthly statement is to be submitted by all DDOs in the enclosed format by or before 10<sup>th</sup> of every month.
