In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of **Miss Asifat Ayoub Sister of Rayees Ahmad Malik R/o Malikgund Tehsil and District Shopian** as **Jr. Assistant** in the pay scale of **Rs.5200-20200 + Grade pay of Rs 1900/-** under **SRO-43 of 1994** against an available vacancy identified by the Deputy Commissioner, Shopian vide his letter No. DCS/Estt/16/380-82 dated 09-06-2016 in Revenue Department, in District Shopian.

The appointee shall report to Deputy Commissioner, Shopian within a period of 21 days from the date of issuance of this order and shall be allowed to join only production of the following documents/certificates to be verified subsequently:

1. Academic qualification certificate.
2. Date of Birth certificate.
3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.

The appointee shall be initially on probation for a period of two years, if, on verification, the certificate produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio in terms of General Administration Department circular No. 17-GAD of 2012 dated 07.6.2012.

Further, the salary of the appointee shall not be drawn and disbursed to the appointee unless verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner, Shopian. She shall furnish an affidavit to the effect that in case of any adverse report about his character and antecedents, She shall have no right to claim the appointment as Jr. Assistant in Revenue Department, District Cadre Shopian and his appointment shall be deemed to have been cancelled ab-initio.
