ORDER

The applicants had levelled allegations against the then presiding officer of the said court and the same have no implications on the case now. - 3) Thus, for the reasons aforesaid, both the applications in hand for transfer of the appeals are dismissed. Both parties are directed to appear before the court of the Additional Deputy Commissioner (Commissioner Agrarian Reforms), Rajouri on the first court day of the first week of August, 2015. Interim directions, if any, shall stand vacated. The case file be relegated to records after due completion.
