1. *The payment of residual leave salary shall be made after completion of all codal formalities.*
2. *The DDO shall ensure fairness of expenditure under rules.*
3. *The DDO is personally responsible who shall certify that the incumbents detailed in the annexure to this order have not paid leave salary already or the leave salary stands sanctioned previously.*
4. *The residual leave salary shall be released after re-calculation for grant of arrears of leave salary in favour of the official retired w.e.f 01.01.2006 to 30.06.2009 and in no case shall exceed the amount of leave salary payable to the extent of 12.5% in favour of the retirees shown in the allotment order.*
5. *The amount of residual leave salary is released @ 12.5 % due for release & in no case the DDO shall make any deviation/ contravention to the aforesaid Govt. order.*
