**Subject:-** Arrears on account of Salary w.e.f. Oct.2010 to Feb.2013 in favour of Sanjeev Kumar, Settlement Patwari.

**ORDER No: FCR/Writ/ 142/2015**  
**DATED : 05 . 06 . 2015**

a) Whereas, vide this office Order No. FC(Adm) 462 of 2002 dated 05.09.2002, Sanjeev Kumar S/O Pannu Ram R/O. Billawar along with others was appointed as Patwari as per the selection provided to this office by Service Selection Recruitment Board ;

b) Whereas, on 23.10.2009, Hon'ble High Court passed an order on 23.10.2009 in SWP No. 258/2003. CMP No. 271/2003 titled Sanjeev Kumar v/s State of J&K and others as under ;

*" In the circumstances, selection/ appointment of private respondent No.4 which is impugned in the present petition, is stayed. He shall not be permitted to attend his duties and paid salary henceforth."*

c) Whereas, vide this office letter No. FCR/Writ/1482/09/J dated 18.05.2010, Principal R.T.I, Jammu was directed to implement the Hon'ble Court Order dated 23.10.2009;

d) Whereas, vide this office letter No. FCR/Writ/1482/09/J dated 14.12.2010, Deputy Commissioner, Kathua was asked to send the compliance report of the said court order ;

e) Whereas, Deputy Commissioner, Kathua, vide letter No. DCK/HAD/2010-11/1849-5 dated 16.12.2010, informed this office that salary of Sh. Sanjeev Kumar S/O Pannu Ram R/O Billawar Settlement Patwari has been stopped forthwith ;

f) Whereas, on 10.12.2012, in the SWP No.258/2003, CMA No. 1006/2011, Hon'ble High Court at Jammu dismissed the petition for want of prosecution ;

g) Whereas, vide this office letter No. FCR/Writ/1482/09/J date 05.03.2013, direction was issued to Deputy Commissioner, Kathua to allow respondent No.4 namely Sanjeev Kumar s/o Pannu Ram R/O Billawar, Kathua to resume his duties and release his salary regularly onwards. The decision regarding arrears will have to be taken later on by this office ;

h) Whereas, vide office No. DCK/Adm/2013-14/158 dated 24.05.2015, Deputy Commissioner, Kathua, informed this office that Sanjeev Kumar, settlement Patwari has been allowed to resume his duties ;

i) Whereas, Regional Director, Survey and Land Records (Ex-officio Settlement Officer), Jammu vide his letter No. RDS&LR/Estt/N/14/567 dated 10.02.2015 recommended this office that the arrears on account of salary w.e.f. October 2010 to February 2013 be released in favour of the incumbent ;

j) Whereas, vide this office letter No. FCR/Writ/1482/09/J dated 02.03.2015, Deputy Commissioner, Kathua was asked to furnish report to the effect that Sanjeev Kumar, Settlement Patwari had performed his legitimate duties regularly for the period 10/2010 to 02/2013, for which arrears of salary are claimed ;


k) Whereas, vide letter No. DCK/Adm/2015-16/213 dated 16.05.2015, Deputy Commissioner, Kathua informed this office that Sh. Sanjeev Kumar, Settlement Patwari remained present and performed his duties as Patwari Halqa Dungara from October 2010 to 13.06.2011 and in Tehsil Settlement office, Billawar w.e.f 14.06.2011 to 19.03.2013 ;

Therefore keeping in view the above facts and adhering to the principles of natural justice , sanction is hereby accorded to the release of arrears in favour of Sh. Sanjeev Kumar, Settlement Patwari w.e.f. October 2010 to February 2013. The funds shall also be earmarked accordingly in

favour of the concerned Drawing and Disbursing Office after getting requisition from him on this account.
