5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.
6. All other relevant certificates/Documents required under norms.

The candidature of the appointees shall be cancelled without any notice in terms of the circular instructions issued by General Administration Department vide circular No. 17-GAD of 2012 dated 07/06/2012, if any of the testimonials/certificates mentioned above is found fake or forged.

The Deputy Commissioner, Rajouri shall take precautions to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/ Institution/ department before drawing their salary and shall immediately take up the matter with this Office, in case any certificate of selected candidate is found/proved false or fake or forged.

The appointees shall be on probation for a period of two years and if on verification of the certificates produced by the appointees one or more is (are) proved to be fake or false or forged, the appointment shall be cancelled ab intio.

The salary of an appointee shall not be drawn till satisfactory report about verification of his character and antecedents is received from Inspector General of Police (CID) to whom a reference shall be made by the Deputy Commissioner concerned.
