Subject: Rationalization of Budget Heads under Major Head: 2053-District Administration.

#### <u>Circular</u>

It is for the information of all that the rationalization in the Head of Accounts has been effected for the Financial Year 2023-2024 in accordance with the changes that has been taken place both in the structure and functions of the Revenue Department.

From the Financial Year 2023-24, the existing 14 schemes operating in the Revenue Department have been merged and only following nine Sub Heads shall operate under Major Head: 2053-District Administration, Revenue Department clubbing the sanctioned strength thereafter under the main scheme:

- 2. 2205 Settlement Commissioner
- 3. 1046 Tehsils
- 4. 1049 Deputy Commissioners
- 5. 2310 SDMs/ADOs
- 6. 1048 Divisional Commissioners
- 7. 1052 Revenue Training Institute
- 8. 1209 Management of Government Estates
- 9. 0569 Agrarian Reforms (FCR)

The above arrangement shall not involve any reduction or increase of budgetary allocations of any Drawing and Disbursing Officer (DDO). The allocation shall continue to be made by the Officer of Financial Commissioner (Revenue), J&K as per the projections made by the subordinate Drawing and Disbursing Officers and funds received from the Government after prudent check of the demands raised and budget allocated.

All the DDOs are therefore requested to plan their financial transactions. Any difficulty faced shall be resolved for the smooth transition. All DDOs can contact the undersigned for any assistance/clarification.

The detail of existing schemes and new schemes to be operationalized w.e.f. Financial Year 2023-2024 are enclosed as annexures A&B.
