Whereas, this office has received a communication No. CBK/R-4792-94 dated 20.04.2015 from Sr. Superintendent of Police, Crime Branch, Kashmir;

2) Whereas, SSP, Crime Branch in the instant letter has intimated that Director General of Police J&K vide his letter No. CB/CLT/2004/277-78 dated 12.04.2004 has forwarded the enquiry report of Addl. DGP, CID, J&K, Jammu to Crime Branch Kashmir mentioning therein that a complaint has been lodged by Shri Ajaz Ahmad and others, residents of village Uri against revenue offices/officials of Tehsil Uri who in connivance with beneficiaries have managed fake and frivolous mutations of "No Man's land" situated at village Paristan Uri influential persons of Uri including politicians, Govt. employees and on the basis of which they are claiming rent from backdate from the Army authorities.

3) Whereas, Crime Branch has referred the matter to this office for constitution of team of suitable officers for the examination of the revenue records with subsequent appropriate action in the matter.

Now, therefore, in light of above, a team of following Officers is hereby constituted for examination of the revenue records of village Paristan, Tehsil Uri District Baramulla:-
