Sanction is hereby accorded to the release of funds to the tune of Rs.3.75 lacs (Rupees three lacs sevety five thousand only) under object head "071-Medical Reimbursement" under above mentioned Major Head of Account for the current financial year 2017-18 and placement thereof at the disposal of Tehsildar D.H.Pora as advance of 75% of estimates cost of Rs. 5.00 lacs in terms of Rule 5 of J&K Civil Services (Medical Attendance Cum Allowance) Rules, 1990, sanctioned vide Govt. order No. 29-Rev(NG) of 2018 dated 08.02.2018 to meet the expenditure in connection with Kidney transplant surgery of Jan Aijaz son of Mohd Yousuf Wagay, Jr. Assistant at SKIMS Sringar subject to the following terms and conditions:-

- i) The funds are available with the department under relevant head;
- ii) The treatment shall be admissible under rules and the reimbursement shall be restrict to the admissible items only;
- iii) The payment shall be released after fulfillment of all codal formalities;
- iv) The Red Account/adjustment bill shall be furnished to the Accountant General J&K Jammu/Sriangar in respect of advance within one month after incurreing the expenditure but invariably before close of the relevant financial year;
- v) The terms and conditions as laid down under rule 14.29-A of J&K Financial Code Vol. I shall be adhered to.
- vi) The pyment shall be made in form of demand draft directly to the concerned hospital i.e. SKIMS.
