

In pursuance of Government Order No. 268-Rev(NG) of 2017 dated 21/11/2017, sanction has been accorded in relaxation of Rule 14(7) of the J&K, Civil Services (Decentralization) Recruitment Rules, 2010 notified vide SRO 375 dated 21/10/2010 to the revalidation of waiting list of District Jammu beyond the date of its expiry (viz 30/08/2017) upto 30<sup>th</sup> November, 2017. Accordingly **Smt. Pooja Devi D/o Ghar Dev Sharma R/o Bain Bajalta Mohalla Malhari Jagir Jammu under OM category** is hereby appointed as Junior Assistant in the Revenue Department, District Cadre Jammu under **SRO-202 of 2015 dated 30/06/2015.**

The appointees shall report to Deputy Commissioner, Jammu within a period of 21 days from the date of issuance of this order subject to the following conditions:

1. **Genuineness of Academic qualification certificate/ Date of Birth certificate/ Permanent Resident Certificate and all other relevant certificates/Documents required under norms.**
2. **The interim arrangement, if any, made against the above post(s) on deputation or temporary basis shall be deemed to have been terminated forthwith and the incumbent if in service reverted to his original cadre.**
3. **The posts are available as on date and stand referred to the J&K Service Selection board.**
4. **The appointment in District Cadre is not transferable from one District to another and change of cadre is not acceptable.**

5. The appointees shall have to necessarily work for a period of 05 years on the post against which she has been appointed and such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years in terms of SRO-202.
6. The appointment of the said candidate shall be governed by "New Recruitment Scheme" as per SRO-202 of 2015 dated 30/06/2015.
7. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
8. The appointment of the candidate is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
9. The appointments are governed under the relevant provisions of SRO-375 dated 21/10/2010 issued by the General Administration Department.
10. If the candidate does not join within the stipulated period, she would be informed through leading news papers to report in the office of Deputy Commissioner, Jammu otherwise her services would be terminated under rules, under an intimation to this office.
11. The officer responsible for receiving/accepting joining report of new appointee shall solicit "No Objection Certificate" from Labour and Employment Department, to the effect that the name of the concerned appointee has been deleted from the list of eligible beneficiaries under "VSA" as mentioned by the concerned department/respective District Employment & Counseling Centre, as well as from District Industries Centre (DIC).
12. The appointment order will be governed by Circular Instructions issued by the General Administration Department vide Circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.
13. The Deputy Commissioner, Jammu shall ascertain genuineness of the qualification certificates/ documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing salary of the appointees. Deputy Commissioner, Jammu shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/ forged, for further course of action. If on verification the certificates produced by the



appointee are proved to be fake/forged, the appointment shall be cancelled ab initio.

14. The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
15. In case of receipt of an adverse report and on confirmation thereof by the State/ Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.


