3. Permanent Resident certificate.
4. Medical Fitness certificate.
5. Character verification through C.I.D.
6. All other relevant certificates/Documents required under norms.
7. Undertaking from the applicant to the effect that she will look after the children even if she re-marries and that the onus for bringing up the orphan children shall always lie on the appointee.

The candidature of the appointee shall be cancelled without any notice in terms of circular instructions issued by General Administration Department vide circular No. 17-GAD of 2012 dated 07.6.2012, if any of the testimonials/certificates mentioned above are found fake or forged.


