- 1 - Whereas, based on the recommendations of the J&K Service Selection Board, the Revenue Department vide letter No. Rev/NG/237/2013 dated 04/10/2016 forwarded select list of candidates for the post of Junior Assistant (District Cadre Jammu) to this Office for issuance of appointment orders;
- 2 - Whereas, accordingly vide this Office Order No. FC(ADM) 207 of 2017 dated 03/07/2017 formal appointment order was issued in favour of Sh. Varun Sanotra S/o Durga Dass R/o H.No. 165 Lane No. 6 New Plots Jammu under OM category as Junior Assistant, District Cadre Jammu in the Revenue Department and was directed to report to the Deputy Commissioner, Jammu for further adjustment;
- 5 - Whereas, the Deputy Commissioner, Jammu vide letter No. 7848-Rev-Adm-PF-30-2017 dated 10/02/2018 intimated that Sh. Varun Sanotra S/o Durga Dass R/o H.No. 165 Lane No. 6 New Plots Jammu resigned from the service on 08/02/2018 and has forwarded the resignation of Sh. Varun Sanotra to this office for further necessary action;
- 6 - Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that Sh. Varun Sanotra S/o Durga Dass R/o H.No. 165 Lane No. 6 New Plots Jammu, Junior Assistant was still on probation and has not completed the probation period. Consequently, the official is liable to be discharged from the service, by terminating his probation in terms of Rule 21(2)(a), on his own request.
