As recommended by the J&K Service Selection Board, Jammu and endorsed by the Administrative Department vide their letter referred to above, **Sh. Sunit Singh S/o Shadi Lal R/o Sharote Thathri Doda under SC category** is hereby appointed as Junior Assistant in the Revenue Department, District Cadre Anantnag.

The appointee shall report to Deputy Commissioner, Anantnag within a period of 21 days from the date of issuance of this order and the Deputy Commissioner, Anantnag shall allow the selected candidate to join only after verifying and establishing genuineness of all the documents as per eligibility criteria including Qualification/Category Certificate/PRC/Domicile status of the candidate in the concerned district for a period not less than 15 years. The appointment of the candidate further shall be subject to the following conditions:

1. **Genuineness of Academic qualification certificate/ Date of Birth certificate/ Category Certificate/Permanent Resident Certificate and all other relevant certificates/Documents required under norms.**
2. **The interim arrangement, if any, made against the above post(s) on deputation or temporary basis shall be deemed to have been terminated forthwith and the incumbent, if in service, reverted to his original cadre.**
3. **The posts are available as on date and stand referred to the J&K Service Selection Board.**

4. The appointment in District Cadre is not transferable from one district to another and change of cadre is not acceptable.
5. The appointment of the said candidate shall be governed by "New Pension Scheme" as per SRO 400 of 2009 dated 24/01/2009.
6. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
7. The appointment of the candidate is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
8. If the candidate does not join within the stipulated period of 21 days, the Deputy Commissioner concerned shall inform the candidate through leading news papers to report in his office within 7 days otherwise his services would be terminated under rules, under an intimation to this office.
9. The officer responsible for receiving/accepting joining report of new appointee shall solicit "No Objection Certificate" from Labour and Employment Department, to the effect that the name of the concerned appointee has been deleted from the list of eligible beneficiaries under "VSA" as mentioned by the concerned department/respective District Employment & Counseling Centre, as well as from District Industries Centre (DIC).
10. The appointment order will be governed by Circular instructions issued by the General Administration Department vide Circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.
11. The Deputy Commissioner, Anantnag shall ascertain genuineness of the qualification certificates/ documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing salary of the appointee. The Deputy Commissioner, Anantnag shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged, for further course of action. If on verification the certificates produced by the appointee are proved to be fake/forged, the appointment shall be cancelled ab initio.
12. The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).

13. In case of receipt of an adverse report and on confirmation thereof by the State/ Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
