2. Academic Qualification Certificate
3. Permanent Resident Certificate
4. Medical fitness Certificate
5. Category certificate, if any

6. Character and antecedents Certificate through CID
7. All other relevant Certificates / documents required under norms
8. The candidature of the appointee shall be cancelled without any notice in terms of Circular instructions issued by General Administrative Department vide Circular No. 17-GAD of 2012 dated 07.06.2012, if any of the testimonials / certificates are found fake forged
9. The concerned Deputy Commissioner, shall take precaution to ascertain genuineness of the qualification certificates / documents and shall verify the certificates confidentially from the concerned Universities / Institutions / department before drawing their salary and Deputy Commissioners shall immediately take up the matter with this office, in case, any certificate of appointee is found / proved false / fake / forged for further course of action
10. The appointee shall be on probation for a period of 02 years and if on verification of the certificates produced by the appointee are proved fake & forged, the appointment shall be cancelled abinitio
11. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report about verification of his character and antecedents is received from Inspector General of Police (CID) to whom a reference shall be made by the Deputy Commissioner, concerned.


