**Subject: - Filing Annual Property Returns by officers/  
officials working in Revenue Department.**

**C I R C U L A R**

During a meeting taken by Hon'ble Minister for Revenue, it was desired that the process of filing of Annual Property Returns by the Revenue officers/officials needs to be pursued on priority by the Controlling Officers. Such Circular Instructions have already been issued earlier vide Financial Commissioner, Revenue, J&K Circular No. FC(Adm-Misc)02/2015 dated 30.01.2015 under **J&K Public Men and Public Servants Declaration of Assets & other Provisions Act 1983.** The Hon'ble Minister has further desired that one copy of Annual Property Returns filed by Patwaries working in different wings of the department be submitted to the Grievance Cell setup in the Administrative Department and headed by the Deputy Secretary to Government, Revenue Department. It was also desired that those Patwaries/Girdawar-Qanoongos who have already filed their Annual Property Returns 2014-15 shall send a copy thereof directly to the above Grievance Cell for the information of the Hon'ble Minister.

Accordingly, it is enjoined upon the two Divisional Commissioners and all Deputy Commissioners/ Regional Director, Survey and Land Records of the State to ensure that within 15 days of the issuance of this Circular one copy of Annual Property Returns 2014-15 of Patwaries/Girdawar-Qanoongo is sent to the Grievance Cell setup for this purpose. Failing which action as warranted under law shall follow. It may also be noted that no further extension of filing the property returns shall be granted.
