Whereas, based on the recommendation of J&K Service Selection Board, the Revenue Department vide letter No. Rev/NG/237/2013-III dated 24.01.2017 forwarded the select list of candidates for the post of Jr. Scale Stenographer in the Revenue Department (Divisional Cadre) to this Office for issuance of appointment orders; and

Whereas, pursuant to above referred communications, appointment orders of Junior Scale Stenographer Divisional Cade were issued by this Office and the appointees were directed to report to Divisional Commissioner, Jammu for further adjustment; and

Whereas, Divisional Commissioner, Jammu vide his letter referred to above intimated that the four selected candidates, namely, **S/Shri Ankush Sharma S/O Ashok Kumar Sharma, Sunil Kumar S/O Devi Dass, Bharat Bhushan S/O Prem Paul and Rakesh Kumar Gupta S/o Jagdiah Raj**, did not join in his office despite lapse of prescribed period of 21 days.

Whereas, as per Revenue Department's letter No. Rev/NG/237/2013-II dated 20.12.2017, it was intimated to issue cancellation orders immediately in respect of the candidates who did not join, so that the candidates falling next in order of merit (Waiting list) are considered for their appointment against the post of Jr. Scale Stenographer in the Revenue Department.

Now, therefore, in view of the above, appointment of **S/Shri Ankush Sharma S/O Ashok Kumar Sharma, Sunil Kumar S/O Devi Dass, Bharat Bhushan S/O Prem Paul and Rakesh Kumar Gupta S/o Jagdiah Raj**, as Junior scale Stenographers in Divisional cadre Jammu in the Revenue Department, is hereby cancelled.
