As recommended by the J&K Service Selection Board Srinagar and endorsed by the Administrative Department vide their letter referred to above, Sh. Chander Parkash S/o Suk Dev R/o H.No.-242 W.No-05 Barrian Udhampur under OM/SC Category District Udhampur is hereby appointed as Jr. Assistant in the Revenue Department (District Cadre Udhampur) in the pay scale of Rs 5,200-20,200 grade pay of Rs. 1,900/-.

The appointee shall report to Deputy Commissioner, Udhampur within a period of 21 days from the date of issuance of this order for further adjustment as Junior Assistant in District Udhampur. The appointee shall be allowed to join only after production/verification of the following certificates in original.

- Academic qualification certificate. 1.
- 2. Date of Birth certificate.
- 3. Permanent Resident certificate.
- 4. Medical Fitness certificate.
- Category certificate. 5.
- All other relevant certificates/Documents required under norms.
- The appointment order will be governed by Circular instructions issued by the General Administration Department vide circular No. 17-GAD of 2012 dated 07/06/2012 and Order No. 1328-GAD of 2016 dated 07/12/2016.
- The Deputy Commissioner Udhampur shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/ Institution/ Department before drawing his salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged, for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab intio.

- The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
- 10. In case of receipt of an adverse report and on confirmation thereof by the State/Divisional/ District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
- 11. The interim arrangement, if any, made against the above post(s) on deputation or temporary basis shall be deemed to have been terminated forthwith and the incumbent if in service reverted to his original cadre.
- The post is available as on date and stand referred to the J&k Service Selection board.
- The appointment in District Cadre is not transferable from one District to another and change of cadre is not acceptable.
- The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 200 of 2015.
- The inter-se-seniority of the appointee shall be strictly as per his merit in the select list.
- 16. The appointment of the candidate is subject to the outcome of writ petition, if any, pending in any court of law on the subject.
- 17. If any candidate does not join within the stipulated period, he would be informed by this office through leading news papers to report in the office of Deputy Commissioner concerned otherwise his services would be terminated under rules.
- 18. The officer responsible for receiving/accepting joining report of new appointee shall solicit "No Objection Certificate" from Labour and Employment, to the effect that the name of the concerned appointee has been deleted from the list of eligible beneficiaries under "VSA" as mentioned by the concerned department/respective District Employment & Counseling Centre, as well as from District Industries Centre (DIC).
