Whereas, vide above referred communication appointment orders of Junior Assistants of District cadre Doda were issued in favour of 28 candidates by this Office vide order No. FC(Adm) 182/2016 dated 26/10/2016 and the appointees were directed to report Deputy Commissioner Doda for further adjustment; and

Whereas, Deputy Commissioner Doda vide his letter No. 2428/Acctt dated 31/01/2017 referred to above intimated that out of 28 only 23 Junior Assistants reported to his office and three appointees namely **Ms. Renu Devi D/o Sewa Singh R/o Bhagwah, Doda (OM category), Sh. Mohd Rafique S/o Mohd Abdul Rather R/o Koti Chakran Tehsil Doda (OM category) and Sh. Balvir Kumar S/o Swarn Kumar R/o Trikuta Nagar East Extension Sector – 1A Jammu (SC category)** did not join in his office despite lapse of prescribed period of 21 days and also followed by a notice vide his office No. 1984-93/Acctt dated 22/11/2016.
