Whereas, pursuant to above referred communications, appointment orders of Junior Assistants of District cadre Reasi were issued in favour of 09 candidates by this Office vide order No. FC(Adm) 184/2016 dated 26/10/2016 and the appointees were directed to report Deputy Commissioner Reasi for further adjustment; and

Whereas, Deputy Commissioner Reasi vide his letter referred to above intimated that the two appointees namely Varun Sharma S/o Narayan Dutt Sharma R/o Dhonori Nangal Katra, Reasi (OM category) and Rakhil Kumar Jaseyal S/o Mohan Singh R/o Panassa Reasi (OM category), did not join in his office despite lapse of prescribed period of 21 days.
