Whereas, a Committee of Officers was constituted vide Order issued under No.FC-Sett/603/2018 dated; 26.10.2018, for revision of Hidayat Bandobast keeping in view the 1992, 2005 Hidayats and Draft Hidayat-2012, so that the survey and updation of Revenue records is carried out.

Whereas, due to various hiccups and transfer / retirement of Officers/members of the Committee, it has been recommended by the Commissioner, Survey & Land Records, J&K vide No.CSLR/Estt/DILRMP/2020/30 dated: 26.08.2020 to reconstitute the Committee of officers, in order to make the revision in tandem with the latest technologies [CORS] to be adopted for survey and resurvey and caters to the difficulties anticipated on ground, and their proper resolution.

Therefore, in view of the above, the Committee of Officers consisting on following Officers is reconstituted for drafting the Revised Hidayat Bandobast in light of the fact that the activity of Survey, Resurvey shall now be conducted using 'Continuously Operating Receiving Station [CORS] technology, for which purpose, the Committee may study the Rules/ Instructions/ Guidelines, framed by certain States like; Andhra Pradesh, where 'Survey/Resurvey' has been undertaken using 'CORS' technology.
