Whereas, Sh. Yawar Zahoor Mir was appointed as Jr. Assistant in the Revenue Department in District Cadre, Shopian, vide this office Order No. 258 FC(REV) of 2023 dated 02.06.2023; and

Whereas, as per his service records, Sh. Yawar Zahoor Mir, joined as Jr. Assistant in the office of Deputy Commissioner, Shopian on 05.06.2023 and was further posted to Tehsil Office Keller vide Deputy Commissioner, Shopian Order No. 09 DCS of 2023 dated 07.07.2023; and

Whereas, Sh. Yawar Zahoor Mir has tendered his resignation from the post of Jr. Assistant with effect from 24.06.2024, on the grounds that he has been appointed as Accounts Assistant in Finance Department vide Order no. 58- Accts of 2024 dated 20.06.2024; and

Whereas, Divisional Commissioner, Kashmir vide letter no. DivCom/E-7577499/17Misc/Estt/1846-47 dated 24.09.2024, forwarded his resignation to this office.

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the above said official is still on probation and has not qualified the prescribed service for confirmation of probation, on account of which, he is liable to be discharged from the service by terminating his probation in terms of Rule 21(1)(b) of J&K Civil Services Regulations (Classification, Control and Appeal) Rules, 1956, on his own request.

Now therefore, in exercise of the powers conferred under Rule 21(1)(b) of J&K Civil Services Regulations (Classification, Control and Appeal) Rules, 1956 the probation of Sh. Yawar Zahoor Mir S/o Zahoor Ahmad Mir R/o H.No.7, Sidiq Aabad, District Shopian, Jr. Assistant, is hereby terminated and accordingly he is discharged from the Government Service with effect from 24.06.2024 i.e. date of his resignation, on his own request.
