Sanction is hereby accorded to the temporary appointment of Sh.Aman Sandotra S/o late Sh. Mohan Lal R/o Lane No. 2, New Plot, Jammu as Orderly in the pay level SL-1 (14800-47100) against an available vacancy in Revenue Department, in District Jammu in terms of Provisions of SRO-43 of 1994.

The appointee shall report to Deputy Commissioner, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates to be verified subsequently:-

- (i) Academic qualification certificate.
- (ii) Date of Birth Certificate.
- (iii) Domicile Certificate.
- (iv) Health Certificate from the concerned Chief Medical Officer of the District.
- (v) Dependent Certificate issued by the Assistant Commissioner, Revenue
- (vi) No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- (vii) All other relevant document as required under SRO43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

- (a) That he/she shall give an under give an undertaking in the shape of an affidavit to the effect that:-
  - (i) In case an adverse report about his/her Character and Antecedents is received from the Additional Director General of Police(CID), J&K, to whom a reference shall be made by the Deputy Commissioner, Jammu he shall have no right to claim his

appointment, which, shall be deemed to have been cancelled ab-initio.

- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- (b). The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he/she shall forego his right to appointment which shall be deemed have been cancelled ab-initio, without any further notice.
