- 2. The appointee shall report to the Deputy Commissioner, Anantnag, within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join after the production of following documents/certificates (in original), to be verified subsequently:
 - i. Academic/ qualification Certificates.
 - ii. Matriculation/Date of Birth Certificates.
 - iii. Health Certificate from the concerned Chief Medical Officer of the District.
 - iv. Domicile Certificate issued by the competent authority.
 - v. Valid relevant Category Certificate, if any.
 - 3. The above appointment shall further be subject to the following conditions:-

a.

a. That if the appointee has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile district, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment

unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the appointee regarding both relinquishment of proprietorship and stakes if any, in such a self-employment unit /enterprise and recovery to be made and shall also personally monitor its recovery.

b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of Qualification / Date of Birth / Relevant

Category Certificate, etc. is received from the concerned Authorities/Agency.

c. The appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification /category certificate/ any other certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled abinitio.

d. The appointee shall be initially on probation for a period of two years.

e. The appointment of the appointee shall be governed by the "New Pension Scheme," as per SRO 400 of 2009 dated 24.12.2009.

f. The appointee appointed under RBA and ALC/IB category shall be posted in such areas

at least for 7 years.

g. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Service Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

h. The cadre allocated by Appointing Authority/SSB shall not be changed under any
